New Student Referral Incentive Program

Parents reaching out to families in your community of friends, neighbors, relatives and co-workers about St. Thomas School is the primary means by which school communities grow. You can earn a \$750 tuition credit by referring a family who enrolls at St. Thomas School. The Student Referral Incentive Program is for parents or guardians who are paying tuition for students enrolled in Pre-K through grade 8. The program awards a current St. Thomas School family with a \$750 tuition credit for each new family they refer who enrolls.

For a current school family to be eligible for the tuition referral credit:

- ◆ The current family must fill out and submit the referral form.
- ◆ The prospective family must enroll their child(ren) in St. Thomas the Apostle School and remain in attendance for the entire academic school year with all fees current.

Other considerations:

- ◆ Tuition referral credits are non-transferable and hold no cash value.
- ◆ Tuition referral credits are limited to the earliest referring/enrolled family and cannot be shared with other school families.
- ◆ Tuition referral credit consideration is limited to the referral of new families never before enrolled at St. Thomas the Apostle Catholic School.
- ◆ Tuition referral credits apply only to the tuition obligation in the new school year.
- ◆ Referring families will be notified by the Administrations Office of their Incentive Awards, as soon as all requirements have been met.

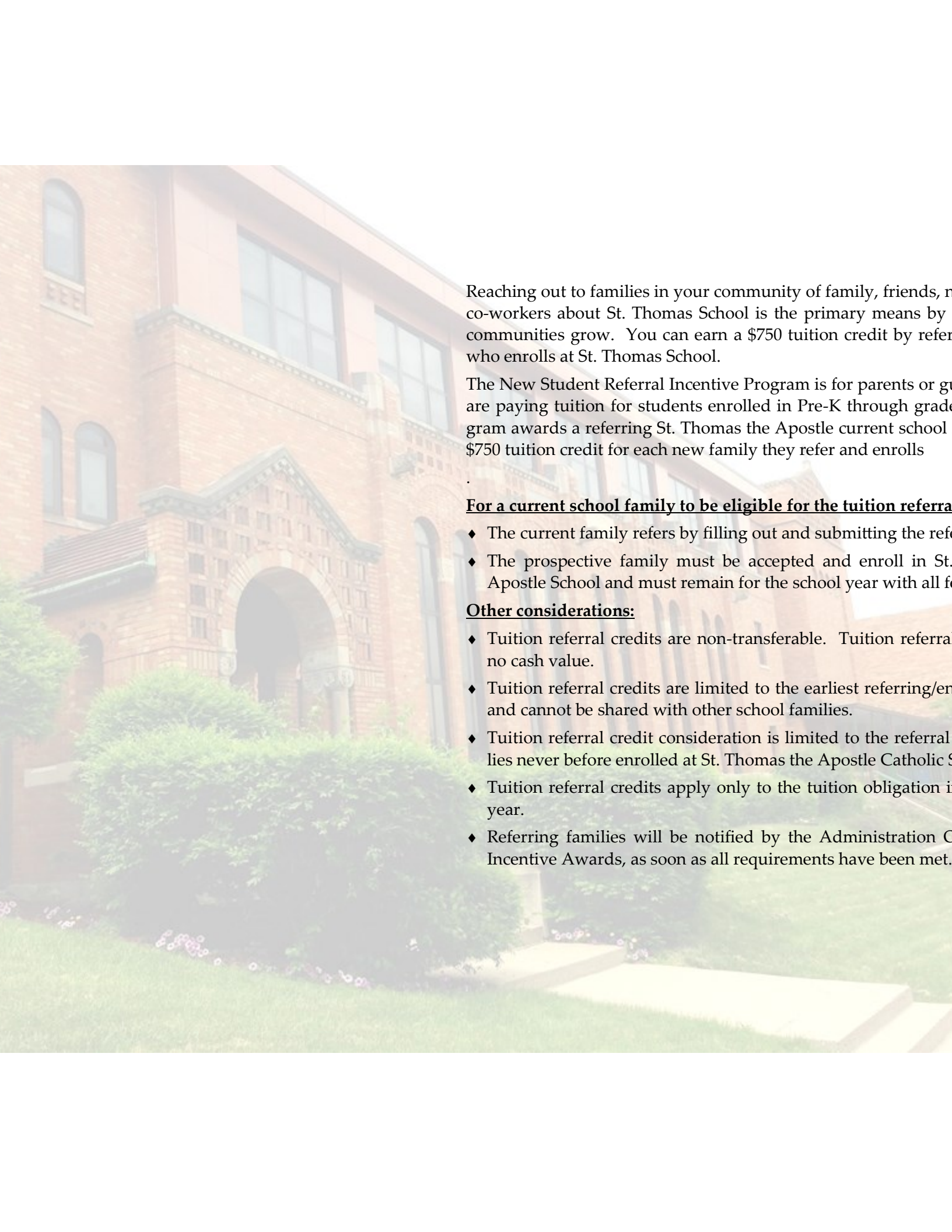

Other considerations:

- ◆ Tuition referral credits are non-transferable. Tuition referral credits have no cash value.
- ◆ Tuition referral credits are limited to the earliest referring/enrolling family and cannot be shared with other school families.
- ◆ Tuition referral credit consideration is limited to the referral of families never before enrolled at St. Thomas the Apostle Catholic School.
- ◆ Tuition referral credits apply only to the tuition obligation in the current school year.
- ◆ Referring families will be notified by the Administration Office of the Incentive Awards, as soon as all requirements have been met.
